Background and Justification

Article 19 of The Convention on the Rights of the Child states "States Parties shall take all appropriate legislative, administrative, social and educational measures to protect the child from all forms of physical or mental violence, injury or abuse, neglect or negligent treatment, maltreatment or exploitation, including sexual abuse, while in the care of parent(s), legal guardian(s) or any other person who has the care of the child. Such protective measures should, as appropriate, include effective procedures for the establishment of social programmes to provide necessary support for the child and for those who have the care of the child, as well as for other forms of prevention and for identification, reporting, referral, investigation, treatment and follow-up of instances of child maltreatment described heretofore, and, as appropriate, for judicial involvement.

The South African Government is committed to establish a society that is free from all forms of violence, particularly those perpetrated against the most vulnerable persons.

The Criminal Law (Sexual Offences and Related Matters) Amendment Act, 32 of 2007, (hereinafter referred to as the Act), was enacted in 2007. The Act stands as a perfect example of a comprehensive piece of legislation that is rich with features that protect the rights of victims against sexual violence. It is an Act that puts emphasis on the progressive development of a Criminal Justice System (CJS) that is victim-centred, responsive and caring. It creates a wide range of new specific crimes to better respond to sexual violence perpetrated against children and persons with disabilities. With its expressed emphasis on leaning on the international trend of service integration, it further provides for the development of a policy framework to guide the integrated management of sexual offences.

Section 62(1) of the Act requires the Minister for the Department of Justice and Constitutional Development (now Minister of Justice and Correctional Services) after consultation with the cabinet ministers responsible for safety and security, correctional services, social development and health and the National Director for Public Prosecutions, to develop and adopt a national policy framework. Section 62(2)(b) further requires that the "Minister must review the policy framework within five years after its publication in the Gazettee....". Section 63 of the Act establishes the Intersectoral Committee on the Management of Sexual Offences Matters referred to as the DG ISC-SO. This committee is required to draft the SO NPF and to make recommendations to the Minister regarding its amendment.

The first SO NPF was formally published in Government Gazettee on 6 September 2013. The process started in 2008 and involved all the implementing stakeholders, including civil society. Therefore, in compliance with the provisions of the Act, the SO NPF was reviewed in 2017/2018 in preparation of its amendment after approval of its review and amendment.



UNICEF provides the South African Government with technical advice to strengthen legislative frameworks and systems and ensure a responsive and protective approach for all children at risk of violence. It is in this context that UNICEF is supporting the Department of Justice and Constitutional Development (the DOJ&CD) together with the JCPS Cluster departments acquiring the services of an experienced service provider in the gender based violence field to assist the amendment of the SO NPF. The amendment must include a five year Inter Departmental Plan (IDP) as the Act provides that it must be reviewed and amended every five (5) years.

PURPOSE

The purpose of these terms of reference is to support the DOJCD to amend the Sexual Offences National Policy Framework (SO NPF) in line with the provisions of the Act and to advance the improvement of its implementation.

Scope of Work

- 1. **Goal and Objective:** The service provider will amend the Sexual Offences National Policy Framework (SO NPF) in line with the provisions of the Act and international norms to advance the improvement of its implementation.
- 2. **Provide details/reference to AWP areas covered:** This work relates directly to achieving Output 3.1: Existence of procedures and services for children in contact with law that are applied and delivered in line with international norms

3. Activities and Tasks:

- 3.1. Attend an inception meeting DOJ&CD and UNICEF within a week (7 days) of agreement sign-off the between the service provider and the UNICEF. The service provider will be provided with the Review Report of the SO NPF of 2013 and all the reports of the implementation of the Act submitted to Parliament that have been printed or in the event such are not within the DOJ&CD, such will be searched by the service provider from Parliament web-site.
- 3.2. Produce Project Plan within a week (7 days) of the inception meeting or earlier.
- 3.3. Submit Draft Zero of the amended SO NPF within 7 days of the acceptance of the Project Plan.
- 3.4. Present the Draft Zero of the amended SO NPF in consultation with the NT ISC-SO and NGOs and make revisions based on consultation inputs to produce Draft 1
- 3.5. Present updated SO NPF (Draft 1) together with the DOJ&CD for adoption by the NT ISC-SO, NGOs and the JCPS Development Committee (the DEVCOMM) to produce draft 2.
- 3.6. Amend and submit revised SO NPF (Draft 2) gathering comments from the adoption processes mentioned in 3.5 above to UNICEF.
- 3.7. Present and revise the amended SO NPF (Draft 2) together with the DOJ&CD Chief Director: Promotion of the Rights of Vulnerable Groups to produce draft 3.
- 3.8. Present the 3rd Draft of the amended SO NPF to the DG ISC-SO for in principle approval. Following this, final formatting and editing of the document into the Final Draft SO NPF.
- 3.9. Submit the final package including: Final SO NPF, inception report, all Consultative Process Reports from all the consultations held with stakeholders for reference and documentation.
- 4. Work relationships: The service provider will report to UNICEF's Child Protection Officer. In addition the service provider will be working closely with the Chief Director: Promotion of the



Rights of Vulnerable who will be assisted by the Project Manager of Sexual Offences Courts Project and the Director: Victim Support and Specialised Services.

This will involve regular meetings with the service provider together with UNICEF and DOJ&CD in preparation for working meetings, consultations, facilitation and presentations to key stakeholders. The service provider will provide regular updates of progress and inform of any unintended findings that are relevant to the amendment of the NPF.
