



## **Terms of Reference**

### **DREAMS Thina Abantu Abasha Program Gauteng Youth Leadership Team**

#### **Introduction**

Adolescents girls and young women are a priority within the DREAMS mandate and in all advocacy efforts and programmes worldwide. In South Africa, 41% population is made up of young people between the ages of 14 and 35 years. The South African National Youth Policy places a commitment towards prioritising the needs of young people with respect to education, health and well-being, economic participation and social cohesion.

The World Health Organization estimated that 36.7 million people were living with HIV in 2015. Sub-Saharan Africa is the most severely affected region, accounting for nearly 70% of people living with HIV worldwide.

It is within this context that in September 2015 the international community committed to ending AIDS by 2030, as part of the Sustainable Development Goals (SDGs). In support of this objective, the U.S. President's Emergency Plan for AIDS Relief (PEPFAR) and supporting organisations, including Johnson & Johnson, launched DREAMS, which is an ambitious \$385 million partnership to reduce HIV infections among adolescent girls and young women in 10 sub-Saharan African countries.

Girls and young women account for 74% of new HIV infections among adolescents in sub-Saharan Africa. The 10 DREAMS countries account for more than half of all the new HIV infections that occurred among adolescent girls and young women globally in 2015. The goal of DREAMS is to support Adolescent Girls and Young Women to develop into Determined, Resilient, Empowered, AIDS-free, Mentored and Safe women.

Within this framework, Johnson & Johnson facilitated workshops focused on insight generation with adolescent girls and young women in nine DREAMS countries in 2016. Feedback from these workshops outlined three principal areas which the girls felt needed to be addressed to instil behaviour change and decrease engagement in risky sexual behaviour. These areas were on employment and employability, leadership skills and sexual and reproductive health. Against this background Johnson and Johnson and UNFPA South Africa Country Office entered into a public-private partnership in June 2017 to implement the DREAMS Thina Abantu Abasha (DREAMS TAA) Programme in KwaZulu-Natal and Gauteng. The purpose of the Programme is to build on the existing PEPFAR DREAMS project and contribute towards the goal of reducing HIV infection amongst Adolescent Girls and Young Women (AGYW).

As a result, Johnson and Johnson in partnership with UNFPA has contracted six Youth to form the official KZN Youth Leadership Team (YLT), to lead the development, implementation and measure the impact of a youth created and led DREAMS Thina Abantu Abasha program

### **Youth Leadership Team**

Johnson & Johnson, in collaboration with on-the-ground and country-specific partners, will for the first time establish a dedicated Youth Leadership Team (YLT) in Gauteng to actualise our commitment to empower young people to participate in developing, leading and implementing a peer to peer education programme by young people for young people.

The YLT gives young people a voice and to guide the DREAMS Thina Abantu Abasha program, and involve young people and youth-serving organizations in advising Johnson & Johnson and UNFPA in the application of the peer to peer program in Gauteng. The YLT demonstrates a shift away from working for young people, to empowering young people to create solutions to ensure youth-friendly approaches and action.

Johnson & Johnson, in collaboration with UNFPA and other stakeholders, intends to expand on the program by launching the program in Gauteng, by establishing a provincial Youth Leadership Team within the greater Johannesburg area.

### **Purpose of the Gauteng Youth Leadership Team**

To work closely with the KZN YLT to amplify the voice of youth representing various networks within South Africa and beyond. Although young people will adapt where relevant, lead and execute the already developed programme, they will receive ongoing guidance and oversight within a governance structure.

Specifically, the **objectives** of the Gauteng Leadership Team are to:

- Work closely with the already established KZN YLT to adapt, lead and implement the DREAMS Thina Abantu Abasha (DREAMS TAA) program by young people for young people with ongoing guidance and oversight within a governance structure;
- Contribute towards the DREAMS goal of reducing HIV infection amongst Adolescent Girls and Young Women (AGYW) by 40%.
- Empower Adolescent girls and young women with correct information and knowledge on sexual reproductive health and rights in target districts, specifically City of Johannesburg and Ekurhuleni.
- Advocate on youth issues within communities and government departments

The **expected result** from having the Youth Leadership Team is:

- Youth-led programme adaptation and implementation that will enhance meaningful participation of AGYW;
- Youth leadership skills enhanced;
- Young people exposed to employment experience;
- Total reach of 100 000 Adolescent Girls and Young Women (AGYW) aged 15-24yrs. within the targeted districts of Gauteng.

### **Roles and Responsibilities of YLT members**

- To work as a team with the KZN YLT to lead the adaptation and implementation of the peer to peer youth program that will deliver against the set objectives;
- Adapt the DREAMS TAA program that will be youth centric, creative and well received within the target population
- Identify and develop the strategies/approaches/tools needed for the implementation of the DREAMS TAA program in Gauteng.
- Launch the DREAMS TAA program to the youth target audience, also including the key strategic partners
- Participate in weekly status meetings with KZN and key stakeholders, reporting back on the adaptation and implementation progress
- Plan, implement and monitor effectively the program in close consultation with all partners and provide monthly reports to all key stakeholders on the Gauteng DREAMS TAA activities.
- YLT is expected to be available at the office (Johannesburg area) for core business hours

### **Contract Period**

YLT members will serve for a period of five months, from August 2018 to December 2018, subject to ongoing performance reviews.

### **Stipend**

- Stipend of the Youth Leadership Team will be ZAR R6000.00 (six thousand Rand) per month.

### **Applications for YLT Engagement**

Johnson & Johnson, UNFPA and PEPFAR DREAMS invite applications for the role of the Youth Leadership Team from young people who meet the following criteria:

- Aged 18-24 as at 1 July 2018
- Minimum educational requirement would be a Matric (Grade 12) certificate
- (Ideally) Resident in either City of Johannesburg or Ekurhuleni district and with current or previous relations within the City of Johannesburg or Ekurhuleni North.
- An active member of your community with a passion for youth development and previous experience in designing and implementing youth development initiatives would be an asset
- Affiliated to one or more youth organisations / networks, i.e. representing a constituency of some kind (faith-based, disability, educational, skills development, gender, leadership, living with HIV, sports, rural development, etc).

### **Criteria for selection**

A panel convened by Johnson & Johnson and UNFPA will review all applications and select shortlisted applicants for interview. No correspondence will be entered into. Preference will be given to applicants from the two priority districts who are active in their communities. Applicants will be chosen to represent a diversity of interest groups, networks and constituencies, and preference will be given to applicants with teamwork qualities, leadership

experience, communication skills, innovative approaches and commitment to furthering youth development.
